Objective

- Offer an alternative license for the convenience of users enabling them to acquire patent rights necessary for the DisplayPort Specifications (see next slide) from multiple patent holders in a single transaction as an alternative to negotiating separate licenses



Coverage

- A patent is essential if one or more of its claims is infringed by implementation of one or more DisplayPort (“DP”) Specifications defined in

Coverage

- Each patent is essential to one or more of the DisplayPort Specifications (see previous slide)
- Patent holders submitted patents for evaluation of their essentiality by independent patent experts
- Worldwide coverage (including essential counterparts)
- Licensors and their Affiliates include all essential patents
- Coverage from first release date of the DP Specification

- New Licensors and essential patents may be added at no additional royalty for present license coverage during the current term; coverage for entire term

DisplayPort License Terms [®]

- **Royalty is US \$0.20 for each DisplayPort Product (without regard to number of DP applications in a single product) Manufactured or Sold in a country with one or more DisplayPort Essential Patents**
 - Includes right to make, use and sell
 - Royalties are payable for DisplayPort Products from January 1, 2013, forward
- **Maximum annual royalty payable for a Legal Entity and its Affiliates is \$7M**

Term

- **Current Term through December 31, 2025**
- **Renewable for successive 5-year periods for the life of any Portfolio patent on reasonable terms and conditions**
- **Rate Protection on Renewal – royalties for license grant will not increase by more than 20% at each renewal**



Other Important Provisions



- **Most Favorable royalty rates clause**
- **Licensee data is protected as confidential**
- **Grant-back on essential patents similar in scope to license grants**
