## Objective

• A license for the convenience of users enabling them to acquire patent rights necessary for the ATSC 1.0 Standard from multiple patent owners in a single transaction as an alternative to negotiating separate licenses





## Coverage

- Each patent is essential to the ATSC 1.0 standard as defined in the ATSC Patent Portfolio License
- Patent holders submit patents for evaluation of their essentiality by independent patent experts
- Worldwide coverage including essential counterparts
- Licensors and their Affiliates include all essential **ATSC 1.0 patents**
- Copies of the ATSC 1.0 standard specifications are published by the Advanced Television Systems Committee





### Coverage

- Attachment 1 to the License is a list of patents updated quarterly to add new essential ATSC 1.0 patents

- New Licensors and essential patents may be added at no additional royalty during the current term, and coverage is provided for the entire term of license

# **ATSC License** Sublicense Category **ATSC Receiver Products**

• ATSC Receiver Products capable of demodulating and decoding an over-the-air, **RF terrestrial broadcast signal in** compliance with the ATSC 1.0 Standard



## **ATSC License Terms: ATSC 1.0 Receiver Products**

- \$5.00 per ATSC Receiver Product from January 1, 1998 through December 31, 2016 (coverage from December 24, 1996)
- \$1.50 per ATSC Receiver Product from January 1, 2017 December 31, 2020
- \$1.00 per ATSC Receiver Product from January 1, 2021 forward
- Alternatively, Licensees may elect, with written notice to MPEG LA, a further reduced royalty of \$1.00 per ATSC Receiver Product from the later of January 1, 2017 or the receipt of such notice with 30-day right of termination on or after January 1, 2021
- Royalty paid includes right to make, have made, sell, offer for sale, import, and for an End User to use the ATSC Receiver Product





### **Other Important Provisions**

- Most Favorable royalty rates clause
- Licensee data is protected as confidential
- Grant-back on essential patents similar in scope to license grants
